#### 18. Gates -

- a. All the locks and chains for the gates along the levee have been removed and all gates are open. (See Photos) <u>We recommend LCWA staff meet with LA County to determine a new approach to secure this property. We</u> <u>recommend adjusting the fence line location to provide a thoroughfare along levy path.</u>
- 19. Trails
  - a. Vehicles driving along the accessways have created large ruts in the roadways. <u>Tidal Influence staff will work with the leasee to minimize ruts once major rain events have past.</u>
  - b. Dry branches have been observed around the sites trails. These will be repurposed/removed. (See Photos) <u>Tidal Influence staff will work to coordinate/plan a way to repurpose or remove this material from the site over the</u> <u>coming months. (See Photos)</u>
- 20. Fences
  - a. A fence breach has been observed along the levy fence line and is part of a homeless encampment area. (See Photos) <u>Tidal Influence staff will coordinate to patch this breach once the encampment is remediated.</u>
- 21. Homeless
  - a. An encampment that was cleared has returned and the individual has been observed walking through the site several times. A staircase and sitting area have been carved into the levy next to the encampment. Large amounts of dried vegetation have been collected and stored near the encampment. Tidal Influence staff have posted "No Trespassing" signage up to increase enforcement in this area, but all signs have been taken down and moved onto another fence line, likely by the encampment inhabitant. (See Photos)

## LOS CERRITOS WETLANDS STEWARDSHIP PROGRAM REPORT, APRIL 26TH – JULY 12TH, 2019

#### Los Cerritos Wetlands Authority

#### **Nature Walks**

Raptor Ramble, Heron Hike, Turtle Trek

Nature walks have attracted big crowds in the past three months with May and June each hosting around 20 attendees each and July's Turtle Trek host a whopping 80 people from the community. (Figure 1). Each tour immersed visitors in the unique habitats of Los Cerritos Wetlands and allowed them gain new perspectives on the purpose of these rare environments. May's springtime tour caught the Hellman Ranch parcel as the fields of invasive mustard were in full bloom and towered over nature walk guests demonstrating the level of infestation to be dealt with when the land is restored. Guests in June observed seasonal breeding behavior of red-winged blackbirds in Marketplace Marsh while also looking for great blue herons. July's nature walk hosted an entire Cub Scout troop and each young scout had an opportunity to see the Pacific green sea turtle for the first time in their life. Whether attendees were first-time visitors or returning veterans, everyone gained a new experience in the diverse habitats of Los Cerritos Wetlands. Each walk begins at the northeast side of 1st Street and Pacific Coast Highway in Seal Beach at 8:00 A.M. on the first Saturday of every month. Members of the public are encouraged to attend all three different tours into the Wetlands. #### **Habitat Restoration Events**

88 volunteers braved the warm weather these past three months to offer their help in restoring Los Cerritos Wetlands (Figure 2). While waiting for planting season to come in the late fall, restoration event attendees in the warm summer months helped to ensure the survival of last season's plants by providing them with supplemental water and removing the variety of non-native species that threaten to compete with them. Along with the help of Stewardship Program interns, restoration events also helped to propagate over 500 plants that will be cared for in the onsite growspace until time for planting. Volunteers and interns together removed an impressive **3,405 lbs**. of non-native vegetation from throughout the Zedler Marsh restoration area. **Combined volunteer hours for this quarter totaled 445 hours, producing an in-kind service value of \$10,741**. Restoration events follow immediately after Land Tours on the first Saturday of every month starting right at 10:30 A.M., please contact iwanttohelp@tidalinfluence.com for more information.

#### **Special Events**

In the last week of April, the LCW Stewardship Program hosted the first ever *Bioblitz* events in Los Cerritos Wetlands (Figure 3). Students and community members visited Zedler Marsh to participate in a city-wide citizen science data collection activity that allowed them to document wildlife species on a massive scale. These events provide researchers with incredible amounts of data that otherwise could not have been collected by themselves alone. In addition to digitally capturing native flora and fauna, *Bioblitz* attendees started their event but helping to remove several hundred pounds of invasive shortpod mustard from the upland habitats around Zedler Marsh. LCW will likely continue to host *Bioblitz* events for years to come.

In early May, Atlas Obscura was hosted for two Turtle Treks along the San Gabriel River (Figure 4). The New York chapter of this adventure group requested these tours as part of their visit to California's unique locations. Group members were accompanied by reporters from the New York Times who interviewed tour leaders about the resident sea turtle population.

Towards the end of the month, two Wildlife Biology classes from Long Beach City College attended service-learning events in the Zedler Marsh restoration area. Almost 60 students helped to remove 500 lbs. of non-native vegetation that threatened the success of newly planted native species (Figure 5).

Summer environmental education opportunities have returned to Los Cerritos Wetlands as the city of Long Beach's BeSAFE program returns for another series of wetlands field trips. Children from eleven different parks throughout Long Beach are slated to visit the Wetlands this summer, seven of which will have already been completed by August 1<sup>st</sup> (Figure 6).

#### El Dorado Audubon Society Los Cerritos Wetlands Authority Nature/Bird Walks Report for August 1, 2019

El Dorado Audubon has been leading nature/bird walks for the Los Cerritos Wetlands Authority since 2009. As a local chapter of the National Audubon Society, El Dorado Audubon's mission is conservation of native birds and their habitats and education of members and the community.

Los Cerritos Wetlands is an Audubon Important Bird Area. Our walks encompass the importance of wetlands and Los Cerritos in particular. We recognize the connectivity of the wetlands with the San Gabriel River, Seal Beach National Wildlife Refuge, El Dorado Nature Center and other Orange Coast Wetlands. We continue to draw community members from throughout Southern California and visitors from Austria, Minnesota, Nevada, New Hampshire, Oregon, Sweden, Texas, and Wisconsin.

Guest speakers on our walks covered a variety of topics: Bays and Estuaries of Southern California, Birds of the Pacific Flyway, sea turtles, butterflies, native and non-native wildflowers.

January -- Rain! Five days of rain. We walked in the rain observing water pooling all over the site. It was a beautiful walk with cameras and binoculars tucked away from the rain. Nine species were observed including Dowitcher, Killdeer, Great Blue Heron (hunkered down), Red-tailed Hawk, & White-crowned Sparrow.

February – Rain Continues! Heavy rain since early morning hours canceled walk. Observers for 1/2 hours documented 5 species – Mallard, Great Blue Heron, Great Egret, Snowy Egret & Red-winged Blackbird.

March – Highlights included Peregrine Falcon and a Scrub Jay chasing a Snowy Egret. Other highlights included the first swallow of the season -- Northern Roughwinged Swallow and Cliff Swallow and Lesser Goldfinch, White-crowned and Lincoln Sparrow.

April – Highlights on Hellman lowlands included Peregrine Falcon and a Scrub Jay chasing a Snowy Egret. Northern Rough-winged Swallow, Cliff Swallow, Lesser Goldfinch, White-crowned Sparrow and Lincoln Sparrow in addition to several species of hawk and Belted Kingfisher for a total of 31 species. April – Zedler Marsh highlights included Anna's and Allen's Hummingbird, shorebirds, Osprey, Blue-Gray Gnatcatcher for a total of 29 species

May – Spring has sprung with native and non-native flowers in bloom. Hellman lowlands included Killdeer, Greater Yellowlegs, herons, egrets, Cooper's Hawk, Redtailed Hawk, Black Pheobe, Say's Pheobe, Barn Swallows, Hooded Oriole, and Common Yellowthroat for a total of 29 species. Zedler Marsh highlights included Hooded Oriole, Cassin's Kingbird, Northern Rough-winged and Barn Swallow for a total of 19 avian species.

June – It's summer with the typical overcast morning sky on the Hellman lowlands. Highlights included Meadowlark, Lesser Goldfinch and Red-winged Blackbird for a total of 20 avian species. The sunset walk on Zedler Marsh yielded Cliff Swallow, Song Sparrow, Hooded Oriole and Common Yellowthroat.

July – Summer overcast morning sky continued for the Hellman lowland walk. Hightlight included Barn Swallow, Cliff Swallow, Hooded Oriole and Common Yellowthroat for a total of 18 species observed.

Attached as Exhibit A is the FY 2018/2019 Budget with balances as of June 30, 2019.

#### The Expenditure Report for FY 2018/2019 (Exhibit A) is summarized below:

#### REVENUES

- General Administrative & Operating Revenue is higher than budget projections primarily due to receipt of past due rental payments from the OTD parcel commercial tenant.
- Contracts Revenue is higher than budget projections primarily due to increased wetland restoration services conducted with Orange County Public Works.
- JPA Contribution, Contracts, and Fees Revenue line items are overall lower than budget projections. However, these one-time, annual payments are expected to be received by the end of this fiscal year.
- Staff is awaiting reimbursement from several grants; thus, revenue from Grant and Special Projects has also been minimal. The revenue will be reflected when submitted costs expended under the grant has been approved for reimbursement and the reimbursement is received.

#### **EXPENSES**

- Insurance D & O and General Liability/Umbrella line items are above normal budget projections as the expenditure reflects current policies and the Authority does not expect any additional expenses.
- Audit Services line item is above normal budget projections as the expenditure reflects the final
  payment to the City of Long Beach Auditor and the Authority does not expect any additional
  expenses.
- Miscellaneous Operational Expense Item includes the return of the lease security deposit to the former OTD parcel tenant. The Authority does not expect any additional expenses.
- Grant Management Contracted Services and Consultant Services line items, are above normal budget projections; however, expenditures are offset by reimbursement from contractors, including Orange County Public Works and Synergy Oil, LLC, respectively.
