Hellman

- 1. Gates
 - a. Vegetation was beginning to obstruct the guide rail of the main electronic gate, side gate, and fence line in the vicinity of the main entrance of the property. Tidal Influence staff have conducted the necessary fence line maintenance in these areas to allow for normal operations and access to the site.
- 2. Trails OK
- 3. Fences
 - a. A section of fence line at the southern end of the property that was patched previously has been observed to be cut and signs of unapproved access were noted during the walkthrough. No signs of damage to biological resources were observed. (See Photos)
 - *i.* <u>Tidal Influence staff will make repairs to the portion of affected fence line in the coming months.</u>

- c. During the property patrol, Tidal Influence staff were informed by the lessee of damage to their materials that caused a large portion of the southeast fence line to become compromised. This left the post of the fence line unsecured. The lessee will be coordinating repairs of this damaged portion of the fence line. (See Photos)
 - *i.* <u>*Tidal Influence staff will be monitoring the progress of these fence line repairs.*</u>






