- 9. Status Report on Work Plan Implementation
  - a. Land Management Update

Eric Zahn, Principal Restoration Ecologist for Tidal Influence, provided a brief land management update. Zahn stated the Hellman property had a section of fence line at the southern end of the property that was patched previously has been observed to be cut and signs of unapproved access were noted during the walkthrough. No signs of damage to biological resources were observed. Tidal Influence staff will make repairs to the portion of affected fence line in the coming months. Zahn stated the lock on the southern access gate for Zedler Marsh was found to be off the gate's daisy chain during multiple property patrols. Tidal Influence staff have replaced the lock with a new lock and have reattached it to the daisy chain. Additionally, steps will be taken to ensure smooth operations and access at that property access point to ensure access for the LCWA and its partners. The OTD Parcel water leak has caused vegetation to grow onto the bike path along 2<sup>nd</sup> street. Zahn stated levee gates at Bryan Lease West were found open. Zahn recommended LCWA staff meet with LA County to determine a new approach to secure this property and adjusting the fence line location to provide a thoroughfare along the levee path

#### b. Los Cerritos Wetlands Stewardship Program Coordinator Update

Since November, there have been 6 monthly nature walks. The 6 land tours saw approximately 400 community members join. Starting with the Heron Hike in November, Raptor Ramble in December and the Turtle Trek in January and then the cycle continued in order. From Fall to winter and now into Spring on each trip was greeted with a variety of different flora and fauna species.

Since November the LCWA has hosted 6 monthly habitat restoration events as well. In the past 6 months LCWA has hosted 225 volunteers who helped remove 210lbs of nonnative species, 235lbs of debris, and installed 735 containers of native species in the CSS, marsh buffer and mulefat scrub to help restore endangered Belding's savannah sparrow, least Bell's vireo habitat and much more. All of this help from the community resulted in 450 hours of volunteer work time contributing\$13,260 of in-kind services.

LCWA hosted 4 additional habitat restoration events at Zedler marsh thanks to the eager community that wants to get involved. In December LCWA hosted two separate field trips for a Marine Biology class and Wildlife Biology class from Long Beach City College. The 58 college students helped spread mulch as well as sightsee and learn about restoration ecology. These two classes are expected to join again in May again thanks to a longstanding partnership. A new partnership was formed through LA's Metropolitans Districts new Resiliency, Sustainability and Innovation office that joined in January to get outside and learn about some of the last remining open space in the Long Beach that is within their range. LCWA also had a returning AP Environmental class join again to get their hands dirty and propagate salt marsh plants. These additional events have resulted in an additional 102 volunteers that helped install1 44 native container plants, propagate 25 salt marsh gallon plants which contributed to 156 hours and \$4,355 of in-kind services.

Mary Parsell stated this report covers November 2022 through April 2023. This winter two scheduled walks were canceled, and one was cut short due to rain. Parsell stated members participated in the in-person meeting regarding the restoration design of the Hellman property in Seal Beach and look forward to the next meeting.

## e. Expenditures Report

Mark Stanley stated this item includes the FY 2022/2023 Budget with balances as of April 19, 2023. Key elements of the Expenditure Report for FY 2022/2023 are summarized here: As the Authority is approximately halfway through the current fiscal year, activity with consultant professional services Grant & Land Management are slightly above projected expenditures. However, the Authority does not expect this expenditure line to exceed the budget. Revenue is also minimal as the Authority's primary receipt of revenue is from its OTD Parcel tenant and annual JPA contributions. Overall Capital Outlay Expenses in relation to grant funding sources are below projections; however, individual funding sources such as State Coastal Conservancy and Miscellaneous are higher than budgeted. The Authority expends grants nearing agreement expiration dates, subsequently, spending them sooner than other funding sources. Administration has minimal activity. However, several expenditures in this category, such as Audit Services and Insurance, generally do not occur until the second and third quarters of the current fiscal year. Staff are awaiting reimbursement from several grants and contracts. The revenue will be reflected when submitted costs expended under the grant have been approved for reimbursement and the reimbursement is received.
