Hellman

- 1. Gates OK
- 2. Trails -
 - Rutted out South LCW trail near the Gum Grove gate due to recent rain. (See Photos)
 - i. <u>Tidal Influence and CCLB staff will conduct trail maintenance throughout the upcoming months to ensure safe access.</u>
 - b. Recent rain impedes dirt road accessibility to the east side of property. (See Photos)
 - i. <u>Tidal influence staff placed barricades as a warning to vehicles and will monitor the situation.</u>



 - i. <u>We recommend LCWA staff meet with LA County to determine a new approach to secure this property. We recommend adjusting the fence line location to provide a thoroughfare along the levee path.</u>
 - b. The Northwest entrance gate was found damaged, currently unable to close. (See Photos)
 - i. We recommend repairing or replacing the gate to secure property access for intended parties.
- 18. Trails
 - a. Tidal Influence staff removed bike ramps along the east portion of the property and will monitor the area for non-beneficial use. (See Photos)
- 19. Fence
 - a. 4 breaches were found along the southeast fence line, exposing the parcel to the bike path. (See Photos)
 - i. <u>Tidal Influence staff will not make additional repairs until the issue with the levee gates is resolved.</u>
- 20. Homeless
 - a. Materials located underneath the cattle grate along levy indicate potential use as an encampment. (See Photos)
 - i. <u>Tidal Influence will continue to coordinate with the LCWA homeless relocation contractor and monitor for non-beneficial use.</u>

Hellman

- 1. Gates OK
- 2. Trails
 - a. Tidal Influence and CCLB conducted trail maintenance on the South LCW trail to ensure safe access.
 - b. Two separate fires, Friday September 8th and Friday September 22nd, occurred along the south side of the Hellman property near Gum Grove Park. The fires were quickly extinguished by the fire department. (See Photos)
 - i. <u>Tidal Influence and associated organizations will continue to monitor the situation.</u>
- 3. Fences
 - a. A fence breach repaired on the southwest side of Hellman, with off-road biking damage to vegetation observed.
 - b. Two fence breaches were found on the southwest side of Hellman, exposing Hellman to Gum Grove Park. (See Photos)
 - i. <u>Tidal Influence staff have made repairs to the fences to secure the property.</u>
