

CHAPTER 3

Draft EIR Revisions

This section references revisions to the Draft EIR based upon (1) clarifications required to prepare a response to a specific comment and/or (2) typographical errors. LCWA has determined that none of this material constitutes significant new information that requires recirculation of the Draft EIR for further public comment under CEQA Guidelines Section 15088.5. The additional material clarifies existing information prepared in the Draft EIR and does not present any new substantive information. None of this new material indicates that the project would result in a significant new environmental impact not previously disclosed in the Draft EIR. Additionally, none of this material indicates that there would be a substantial increase in the severity of a previously identified environmental impact that would not be mitigated, nor that there would be any of the other circumstances requiring recirculation described in Section 15088.5. Changes made to the Draft EIR are referenced here and can be viewed in the individual Draft EIR sections in ~~strikeout~~ text to indicate deletions and in single-underlined text to signify additions in Appendix A of this Final EIR.
